#### **Tourism Minster of Sport and Recreation - Lauren Moss**

LW advised members the visit to Nhulunbuy by Minster for Tourism, Sport and Recreation, Lauren Moss, in early April 2018 was unfortunately postponed. Indicated are the visit will likely be rescheduled for 28/29 June 2018 and it is hoped will coincide with the Northern Territory Tourism Commission meeting.

## **Chief Minister of the Northern Territory – Hon Michael Gunner**

LW advised members, Chief Minister of the Northern Territory, Hon Michael Gunner will be visiting Nhulunbuy on Friday 27 and Saturday 28 April 2018. The Minister will be visiting businesses in Nhulunbuy whilst in town and will attend the Surf Club opening on the Friday evening.

LW also followed up items from the previous meeting in March 2018:

- Large potholes in Dartnall Drive AS stated the Nhulunbuy Corporations Manager Strategic Infrastructure is meeting a contractor to address the remedial works required
- Coffee bush on the town lease MN mentioned there is an Arnhemland Weeds group that
  meet monthly at Dhimurru to discuss noxious weeds. MN advised the group is trying to
  have coffee bush listed in Nhulunbuy as a noxious pest/weed. If successful, this can isolate
  the weed and enable the group to receive funding to eradicate coffee bush in the area
- Tree lopping in South Park LW mentioned there is already steady regrowth occurring. AS
  advised the Nhulunbuy Corporations Manager Strategic Infrastructure is also working on
  having this matter resolved

## **Bunggulwuy Park**

MN brought to members attention holes and tears in the shade sails at Bunggulwuy Park. One sail in particular has two tears on the sail. AS acknowledged visibility of same recently(Sunday) and advised he will ensure the Corporation address this urgently to avoid further damage.
