#### **ROLE OBJECTIVES**

To be a key member of the Nhulunbuy Corporation's Infrastructure team with primary responsibility

for:

- Driving and operating plant and equipment including road sweeper, rigid tipper trucks and civil sized earthmoving plant, tractor & slasher, Ride-on mowers.
- Assisting with civil and building construction.
- Undertaking maintenance and labouring works
- Assist with the maintenance of the Nhulunbuy Town Centre.

#### **KEY ROLE OUTCOMES**

Work as part of a small team as well as independently and have the ability to manage the day-to-day safety, environment, and security aspects of the Works Depot in accordance with regulations and ensure Nhulunbuy Corporation Limited (NCL) policies and procedures are implemented and enforced.

## **WORK DUTIES**

The position description does not act to limit or set specific duties required to fulfil this role, this document serves to describe the role and outline the required outcomes and to set expectations.

All employees are required to have a flexible approach to their work, including undertaking work duties which may fall outside those required of this role. All employees must comply with reasonable and lawful directions.

The position shares responsibility for after hours on-call such that the infrastructure team provides a 24hr/7day response to infrastructure related matters and may require some after-hours/paid overtime.

- Labouring works and projects
- Concreting
- Maintenance and construction of parks and reserves
- Maintenance of the Nhulunbuy Aquatic Centre
- Waste collection and disposal
- Town Centre maintenance
- Nhulunbuy Cemetery Digging of Graves, Burials, Mowing, maintenance etc.
- Plant & Vehicle cleaning, checks, minor maintenance (pre-starts).

Provide training to other employees, where requested.

Work effectively in a team environment, always demonstrating respect and engagement, as well as a commitment to bettering Nhulunbuy and its adjoining leased lands.

Maintain a positive attitude and flexibility to meet the demands of changing works priorities at short notice.
